**SYNOPSIS OF ANNUAL TOWN MEETING  
MARCH 8, 2005**

Article 1. The results of the Town Election are as follows:

## WARRANT ARTICLE RESULTS

Article 2. Negative vote to 1) eliminate in all districts the 3 acre minimum lot size requirement for lots containing areas with slopes greater than 15%; and 2) repeal Article X. C Steep Slopes District, and replace it with a new Article XII-1 – Controls For Slopes and Wetlands. The new Article XII-1: a) retains and clarifies the existing provision that lots containing areas with slopes greater than 15% shall include one contiguous acre of land that is less than 15% slope and does not contain wetlands, b) in the case of multi-family dwellings, requires additional acreage that meets these conditions, c) retains the provision that an erosion and sediment control plan must be approved for construction on slopes greater than 15%; and d) adds a provision that areas with slopes greater than 25% may not be used to satisfy minimum lot area requirements.

Article 3 Affirmative vote to a) change the definition of wetlands so as to be consistent with the newly adopted NH RSA 482-A:2, paragraph X; b) clarify the method by which wetlands are to be delineated; c) clarify current requirements for setbacks from wetlands and surface waters; and d) establish a requirement for a 25 foot buffer from those wetlands greater than 10,000 sq. ft. in area and from ponds in addition to the current requirement for a 25 foot buffer from streams.

Article 4. Affirmative vote to repeal the existing Article XII.F – Signs and replace it with a new section XII.F – Signs which establishes standards for the number, size, height, and illumination of signs and also prohibits certain kinds of signs.

Article 5. Negative vote to specify and define permit requirements pertaining to driveways.

Article 6. Negative vote to amend the New Ipswich Zoning ordinance, Article XII, Section A, Dimensional Controls to allow for 1.5 acres minimum lot size in the Rural District and Steep Slopes District; and to amend the minimum road frontage to be 150 feet in all districts? Approval

of this zoning amendment would also require amending Article XII, Section B, Density Control, to reflect the 1.5 minimum lot size in the Rural District.

Article 7. Negative vote to 1) amend Article XII, Section A., Dimensional Controls and Article XII, B, Density Control by changing the minimum lot size for single family and two family dwellings in the Rural District from 2 acres to 3 acres and by changing the minimum lot size for multi-family dwellings in the Rural District from 2 acres to 4 acres with a minimum of 1 acre per dwelling unit; 2) amend Article XII, A, Dimensional Controls by changing the minimum road frontage in feet in the rural district from 200 feet to 250 feet; and 3) Amend Article XIII, E, Cluster Development, subsection 2.d by changing the words in the first two lines from "The maximum number of allowed house lots in a cluster subdivision shall be one per two acres in the parcel" to "The subdivision shall be one per the minimum lot size in the district in which the cluster subdivision is located."

Article 8. Negative vote to repeal and abolish Article X, Section C, Steep Slope District in its entirety.

Article 9. Negative vote to amend the New Ipswich Zoning Ordinance, Article XII, Section B, Density Control, to allow all land within lot boundaries be used for density and lot area calculation, by adding to the end of the paragraph: "All land within the lot boundaries of the existing lot shall be used to calculate unit density or lot area calculations for the proposed development."

Article 10. Negative vote to amend the New Ipswich Zoning Ordinance, Article XIV, Section A, 1 to have elected rather than appointed Zoning Board of Adjustment members; and to delete Article XIV, Section A, 1 and replace the section as follows: "XIV A.1. There shall be a Board of Adjustment consisting of five members and three alternates who shall be elected in accordance with NH RSA 673:3 and NH RSA 669. The members of the Board of Adjustment shall conform their duties and authority to the provisions of the chapters of NH RSA chapters 673-677."

Article 11. Negative vote to amend Article XVI, A, Administration by adding the following section 9. "The Planning Board shall not appoint any alternate members to the Planning Board whose term on the Planning Board was defeated by election within the three previous years."

Article 12. Affirmative vote to raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amount set forth on the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein totaling \$1,880,057. Should this article be defeated, the operating budget shall be \$1,810,667, which is the same as last year with certain adjustments required by previous action of the town or by law, or, the governing body may hold one special meeting in accordance with RSA 40:13 X and XVI, to take up the issue of a revised operating budget only.

Article 13. Negative vote to approve the cost items included in the collective bargaining agreement reached between the Board of Selectmen and the SEIU (Service Employee International Union) Local 1984, which calls for the following increases in salaries and benefits:

and further to raise and appropriate the sum of One Hundred Twenty-Six Thousand, Seven Hundred Thirty-Three Dollars (\$12,733) for the current fiscal year, such sum representing the additional costs attributable to the increase in salaries and benefits over those of the appropriation at current staffing levels paid in the prior fiscal year.

Article 14. Affirmative vote to raise and appropriate the sum of One Hundred Nineteen Thousand, Seven Hundred and Ninety Dollars and Twenty-three cents (\$119,790.23) for the purpose of maintenance of town roads. (The amount of this appropriation is equal to the amount of funds received from the State Road Block Grant.)

Article 15. Affirmative vote to raise and appropriate the sum of Seventy-Four Thousand Dollars (\$74,000) to be added to the capital reserve funds created previously as directed below:

Article 16. Affirmative vote to raise and appropriate the sum of Twenty-one Thousand Dollars (\$21,000) to support the New Ipswich Library.

Yes votes 1,043 No votes 270

Article 17. Negative vote to raise and appropriate the sum of Thirty Thousand Dollars (\$30,000) for the purpose of consulting services to develop a schedule of impact fees in order to implement the Impact Fee Ordinance adopted by the town in March, 2004 and to authorize the transfer of \$30,000 from the existing December 31, 2004 unreserved fund balance for this purpose.

Yes votes 621 No votes 690

Article 18. Negative vote to raise and appropriate the sum of Forty Thousand Dollars (\$40,000) for the purpose of hiring a part time professional planner. (Responsibilities of the Planner would include: review of all proposed subdivision and site plans for compliance with town policies and sound planning principles; coordination of the review process among town staff, engineers, state agencies and others; and professional planning services such as assistance with comprehensive plan updates, zoning ordinance revisions, capital improvement program development, development of site plan and subdivision regulations and staff support to other committees) and to authorize the transfer of \$40,000 from the existing December 31, 2004 unreserved fund balance for this purpose. If this warrant article passes, the appropriation for this position will be in the following years operating and default budgets.

Article 19. Negative vote to rescind the provisions of RSA 40:13 (known as SB 2), as adopted by the Town of New Ipswich on March 14, 1998, so that the official ballot will no longer be used for voting on all questions, but only for the election of officers and certain other questions for which the official ballot is required by law. (Note: A 3/5 "yes" majority on this question will return New Ipswich to the previous form of town meeting.)

Article 20. Negative vote to raise and appropriate the sum of Six Thousand Dollars (\$6,000) for the purpose of upgrading the phone system at the Town Offices and to authorize the transfer of this amount from the existing December 31, 2004 unreserved fund balance.

Article 21 Affirmative vote to raise and appropriate the sum of Four Hundred Sixty-Five Thousand Dollars (\$465,000) for the purpose of construction and related construction engineering services for the replacement of the Lower Ashby Road bridge over the Souhegan River (NH Dot Bridge No. 137/062, a Town-owned bridge with critical deficiencies and for the purpose of funding the shortfall in the construction and related construction engineering services for the replacement of the Old Country Road bridge over Waterloom Pond (NH Dot Bridge No. 145/089), a Town-owned bridge with critical deficiencies. Upon completion of the construction, the Town will be reimbursed 80% (\$372,000) by the New Hampshire Department of Transportation (NHDOT) through the NHDOT Municipally Managed Bridge Aid Program.

Yes votes 1,078 No votes 256

Article 22. Affirmative vote to raise and appropriate the sum of Eight Thousand, Three Hundred Dollars (\$8,300) for the following pool maintenance: repair of replacement of chlorinator filter gauges, railing cup replacements, pool house floor repair and safety mats, deck fencing, and maintenance equipment and to authorize the withdrawal of this amount from the Pool Capital Reserve Fund previously established for the purpose of maintenance.

Yes votes 1,054 No votes 253

Article 23. Affirmative vote to raise and appropriate the sum of Five Thousand Dollars (\$5,000) for the purpose of painting the two remaining sides



of the Old Town Hall and to authorize the transfer of this amount from the existing December 31, 2004 unreserved fund balance.

Yes votes 767 No votes 542

Article 24. Affirmative vote to raise and appropriate the sum of Twelve Thousand, Five Hundred Fifty-Nine Dollars (\$12,559) for the purpose of funding the following regional health service: Monadnock Family Services \$5,824,; Home Healthcare, Hospice & Community Services \$4,500; St. Joseph Community Services \$1,235; and American Red Cross \$1,000.

Yes votes 903 No votes 400

Article 25. Affirmative vote to raise and appropriate the sum of Ten Thousand Dollars (\$10,000) for the purpose of installing two dry hydrants during the construction of the bridges on Old Country Road over Waterloom Pond and the Lower Ashby Road bridge.

Yes votes 916 No votes 374

Article 26. Negative vote to raise and appropriate the sum of Twenty-Six Thousand, Three Hundred and Fifty Dollars (\$26,350) for the purpose of hiring a sixth full time police officer. (This amount includes salary, benefits, and related employment expenses for a six months period.) If this warrant article passes, the appropriation for this position will be in the following years operating and default budgets.

Yes votes 532 No votes 782

Article 27. Affirmative vote to raise and appropriate the sum of Eight Thousand Dollars (\$8,000) to remove the existing hazardous and deteriorated playground equipment and possible toxic soils beneath the existing wooden playground structure and to authorize the transfer of \$8,000 from the existing Parks & Recreation Maintenance Capital Reserve Fund previously established for this purpose.

Yes votes 815 No votes 494

Article 28. Affirmative vote to raise and appropriate the sum of Twenty-Five Thousand Dollars (\$25,000) for the purpose of purchasing new playground equipment to replace the existing deteriorated and hazardous equipment and to authorize the transfer of \$25,000 from the existing December 31, 2004 unreserved fund balance for this purpose.

Yes votes 818 No votes 490

Article 29. Negative vote to refund 0% of all the tax revenues received from the properties, which are accessed by the use of Middle, Upper Pratt Pond, and private non-public portion of Lower Pratt Roads. Monies collected payable to the Pratt Pond Association Road Committee for use in maintaining and improving these currently private roads.

Yes votes 225 No votes 1,026

Article 30. Affirmative vote to raise and appropriate the sum of Thirty-Five Thousand Dollars (\$35,000) for the preparation of an Engineering Study for the replacement of the Tricnit Road Bridge over Furnace Brook (NHDOT Bridge No. 139/106), a Town-owned bridge with critical deficiencies. The town will be reimbursed 80% (\$28,000) of the engineering costs by the New Hampshire Department of Transportation (NHDOT) through the NHDOT Municipally Managed Bridge Aid Program. This is a non-lapsing appropriation per RSA 32:7, VI.

Yes votes 965 No votes 339

Article 31. Affirmative vote to raise and appropriate the sum of Ten Thousand Dollars (\$10,000) for the purpose of purchasing self-contained breathing apparatus for the Fire Department and to authorize the transfer of \$10,000 from the Fire Department Protective Equipment Capital Reserve Fund previously established for this purpose. (This amount will cover the Town's commitment to the Federal Grant for the \$72,000 awarded to the Town.)

Yes votes 1,071 No votes 234

## **BOARD OF ASSESSORS**

During 2005, we continued to collect data as part of an ongoing five year revaluation cycle. Unlike year past we will no longer attempt to collect all the data and re-assess the town in one year. The present method attempts to collect twenty-five percent of the data over a four year period and every five years reassess the properties based on an analysis of recent sales. This method is required in order to meet the State mandated policy of the State of New Hampshire. It also assures that each community is attempting to meet an acceptable standard of assessing performance. This is critical when determining state aid for education, of which New Ipswich is a significant recipient.

In the recent past we have used Avitar Associates to perform the assessing functions and provide the Board of Assessors with technical expertise. Commencing on January 1, 2006, we will contract with Granite State Municipal Assessing & Consulting Services, LLC. Although we have changed companies, we will continue to have the same assessor, Mr. James Rice. This change will allow the Board of Assessors and Mr. Rice to host informal seminars to inform the public about property assessments. Presently we are considering sessions on current use and reading an assessment card. In the future we may explore how to file an abatement and other subjects which are affected by our town's property valuation. Our goal is to provide the fairest possible assessments for each taxpayer and the better we are informed the closer we can come to achieving our goal.

We are grateful for the expert support of Joanne Meshna, who serves as our assessing technician and secretary along with her many other duties, and for the support we have received from other Boards and the public.

## EMERGENCY MANAGEMENT

This year the town was awarded a grant to develop a Hazardous Mitigation Plan. The federal government has mandated cities and towns to identify hazards and create a plan to mitigate hazards before disasters occur. In many cases grants are available to help towns eliminate hazards before a disaster strikes.

The Emergency Management office has pamphlets and materials available to the citizens of New Ipswich. We are always looking for people to join in our effort to assist citizens in time of need. We invite Amateur Radio Emergency Service operators to participate in emergency communication drills in case of a disaster.

New Ipswich Citizen Corps sent out questionnaires to identify needs and resources in our community. We urge citizens to prepare plans and emergency kits in case of a disaster. In 2005 we have seen natural disasters in many parts of the country, even in our own state. Survival is dependent upon citizen preparedness. We have information and training to assist citizens prepare.

I would like to thank my Deputy Director Richard Lehtonen, Communications Officer George Standley and Lora dePlante, Animals in Disaster Coordinator, for their hours of dedication and help.

Please feel free to stop in to the Emergency Operation Center in the rear lower floor of the town hall. We meet most Tuesday nights at 7:30 p.m. The phone number is 878-4515.

## FIRE DEPARTMENT

Thank you to my staff of fire officers, firefighters and members of the firefighters association, and the Town Office staff for a successful year. Other agencies which need to be mentioned are the State of NH Fire Marshall office, NH Fire Academy and all the Mutual Aid Fire Departments, New Ipswich Police, and the Souhegan Valley Ambulance Service.

We support the local Cub Scout Pack and this year we had a gathering of scouts at the Fire Station to dedicate a small stone marker and the planting of a tree. This was to show appreciation to our sponsorship. Please make a point to stop and take a look. I also need to recognize all the local merchants for all you have done for us this past year. Thank you.

The past year's work load has not decreased. The ongoing involvement with development as well as the inspectional processes, seeking and writing grant applications, recruitment, retention, training of firefighters and maintaining the fleet of fire apparatus has placed a heavy demand on the volunteer time of our firefighters. You will note a substantial increase in the fire budget. This is not only due to energy costs but it is primarily for part time wages for the firefighters. With time being so precious to all of us, the firefighters are no different. Many work extra hours or a part time job somewhere, I would like to see this be the extra part time job. Our firefighters respond to approximately 300+ requests for service or emergencies (285 as of 12/26/05) each year. This does not count hours spent on training and maintaining the fire equipment. As we already are able to reward for services during a forest or wildland fire the plan is to use the same rates of pay.

Federal grant applied for in the amount of \$84,000.00 for new fire protective clothing and diesel exhaust system for the station has not been awarded to us but we have not received a no answer as of yet (12/26/05). Our share would be only 5% matching. This would come from a capital reserve account for firefighter protective equipment. Other grants pending deal with forestry equipment and portable radios.

2006 is the year in the capital improvement plan for the tanker truck replacement. The proposal is to lease purchase the unit due to the expected longevity of service. The present tanker truck has served 28 years, 16 years as a pumper and 14 years as a small tanker truck. I feel lease purchase will be a comfortable fit to the annual budget.

We continue to work to seek and place into service more rural water supplies. Three new dry hydrants went into service and two others are in the works for replacement.

The Fire Department is happy to announce that three new firefighters are close to completing certification level I and two have completed EMT training. Each course involves many hours of classroom time as well as practical training. I am also proud to announce that another local volunteer firefighter will soon have a full time career in the fire service. Never forget the seed started here.

Our business phone number, 878-1364, is always monitored and you can call and leave a message anytime. Burning permit requests are handled Saturday and Sunday mornings, 8:00-10:00 AM, at the Fire Station. During the week from 1:00-3:30 PM most days permits can be picked up at the highway garage and the fire station.

In addition to the above responses, the administrative staff completed over three dozen site plan reviews for development as well as eighty occupancy/oil burner inspections. This involves at least one site visit and many required multiple site visits. Training preparation time includes fire prevention for school children grades K-4 as well as for the firefighters each month.

## **FOREST FIRE WARDEN AND STATE FOREST RANGER**

Your local Forest Fire Warden, Fire Department and the State of New Hampshire Division of Forests & Lands work collaboratively to reduce the risk and frequency of wildland fires in New Hampshire. To help us assist you, please contact your local Forest Fire Warden or Fire Department to determine if a permit is required before doing ANY outside burning. A fire permit is required for all outside burning unless the ground is completely covered with snow. The New Hampshire Department of Environmental Services also prohibits the open burning of household waste. Citizens are encouraged to contact the local fire department or DES at 1-800-498-6868 or [www.des.state.nh.us](http://www.des.state.nh.us) for more information. Safe open burning requires diligence and responsibility. Help us to protect New Hampshire's forest resources. Fire activity was high during the first several weeks of the 2005 fire season, with red-flag conditions issued by the National Weather Service and extreme fire danger in the southern and central portions of the state. This period of increased initial attack activity prompted a 5-day ban on open burning, the first such ban in several years. Despite the dry conditions, the state's largest wildland fire was contained at 29 acres. Our statewide system of fire lookout towers is credited with keeping the fires small and saving several structures this season due to their quick and accurate spotting capabilities. Fires in the wildland urban interface damaged 10 structures, a constant reminder that forest fires burn more than just trees. Homeowners should take measures to prevent a wildland fire from spreading to their home. Precautions include keeping your roof and gutters clear of leaves and pine needles, and maintaining adequate green space around your home free of flammable materials. Ditching was done on Ypya, Cutter, Poor Farm, Temple, Goen, Timbertop, Willard, Joy and Currier. Brush and tree work was done on Mountain View, Kangas, Temple, River, Goen and Playground. Guard rails were installed on Appleton, Binney Hill, Page Hill, Temple and Greenville. Paving was done on Lower Ashby and Temple. Shimming was done on Mason, Goen, Fox Farm and Poor Farm. Mason and Goen were sealed.

Because of all the rain at different times we had washouts on Lower Ashby, North, Mason, Mountain View, Pine, Timbertop, Goen, Boynton Hill, Matson, Locke and Page Hill.

Along with grading dirt roads, we dug several graves, maintained all town buildings, mowed all town grass and spent many, many hours repairing and maintaining all town owned vehicles.

## ZONING BOARD OF ADJUSTMENT

In 2005, the Zoning Board of Adjustment (ZBA) approved ten exceptions, two variances and one equitable waiver of dimensional control. One more special exception and one variance are pending. We spent a great deal of time this year dealing with issues related to our Steep Slopes Ordinance. As the town fills out, more and more applications come in for development on lands that are environmentally vulnerable because of their slope. Lands that are steep have greater potential for problems with runoff and erosion than those that are not. Any parcel with land over 15% grade must be considered for its steep slope implications and the Board has worked hard to develop better guidelines for administering this ordinance.

Clark Baldwin, David Cotzin, Greg Hanselman and Toni Lovell continued to contribute their valuable insights as permanent members, supplemented by alternate member Wendy Freeman. Joanne Meshna continued her excellent service as Secretary to this Board. The Board members are grateful for her expertise in land use matters and for her ability to serve both the Board and the public efficiently and professionally. Small towns with all-volunteer boards are highly dependent on the knowledge and good will of their town employees—we are fortunate to have Joanne in New Ipswich.

We are still in need of volunteers and welcome interested members of the community as participants. This is a chance to find out what is happening in your town and to have an impact on its future—at a crucial time in the history of New Ipswich. The Zoning Ordinance helps to balance the demands of land developers and builders for growth, with a desire to preserve New Ipswich's rural character, scenic beauty and fragile historical and environmental resources. If you are interested in serving on the Board of Adjustment, please contact any member of the ZBA for more information.

The ZBA meets at 7:30 pm on the first Thursday of every month at the Town Office. When necessary and appropriate, the board schedules additional meetings to meet the needs of applicants. Since additional meetings are unbudgeted, the applicant covers their cost. ## OLD TOWN HALL COMMITTEE

Thanks to your approval for an appropriation at our last town meeting, we were able to have the other two sides of the old town hall completed; however, there is still a lot of things left to restore this old historic building.

Our Old Town Hall is a structurally sound building that has been at the same location since 1817, and parts of the building were taken from an older Meeting House that predates the Revolutionary War. The structure has housed Town Meetings, the New Ipswich (Appleton) Academy, and has served as a gym. Like other buildings it has evolved over time and in its present form is a Public Hall.

It is on the National Register of Historic Places and I quote from one of their reports of this old historic building. "Built in 1817 as a town hall and academy, and remodeled in 1869 for use solely as an auditorium for town meetings, the New Ipswich Old Town Hall is a good example of a rural public building which has been altered to meet the changing needs of a prospering country town. Constructed with high architectural quality at a focal point in the town, the structure has evolved from a Federal style building incorporating elements from an eighteenth-century meeting house into an excellent example of rural Greek Revival architecture. The structure played an important role in the educational history of the state and in the political history of the community."

The committee plans to submit another article in the warrant at the next town meeting for funds to continue refurbishing this old historic structure.

## CEMETERY REPORT

The Cemetery Committee would like to thank the townspeople for passing the budget last March. When there was a default budget, the Cemetery budget was often cut below the previous budget to pay for services elsewhere.

We managed by using Community Service Workers, paying the Sexton from the Maintenance Trust Fund to oversee these people, and relying on help from the Highway Department, but overall the cemeteries suffered. This year we have hired Sasner Landscape Company to do the mowing; monuments are being repaired, defective trees are being removed and the fence at Central is having a fresh coat of paint. We are also in the process of expanding South Cemetery by adding the Morrill lot to the east.

There are four sources of income to maintain town cemeteries.

1. Perpetual Care Trust Fund.  
The interest transfers to the Maintenance Trust Fund.
2. Maintenance Trust Fund.  
The money comes from the sale of burial lots, internment fees and interest. Prices have been increased this year. This money is used for capital improvements.
3. Cemetery Budget is for yearly maintenance and sexton's salary.
4. Warrant Article. When there is a major project.

There is ample room in Central Cemetery for expansion but South Cemetery is filling up. Through the generosity of Ed Morrill, .35 of an acre has been made available on the east side to expand. We thank Ed Morrill for his generosity. It will cost \$16,000 to \$19,000 to prepare this area. The money will come from the Maintenance Trust Fund. We want to acknowledge the great service provided to the town by Tim Ojala and Sons in clearing the land and to David Keurulainen and Son for reasonable prices for earthwork. We endeavor to hire locally and competitively when possible. We are asking the town for \$45,000 to dredge the pond at Central Cemetery and to repair the dam. The pond which is over half filled with silt, is a source of recreation, provides water for fire protection personnel to fight fires, and is a source of beauty. The soil removed will be used to grow grass at Central Cemetery and other Town properties in need of topsoil.

A town is often judged by the way its cemeteries look and are managed. Please help us to show that we care for and respect the deceased by continuing to provide funds to maintain these places of beauty by voting for the

budget, passing the warrant article, and leaving a gift to the Perpetual Care Fund in your will.

## POLICE DEPARTMENT

The year 2005 has already passed. It was a difficult year for the police department as we saw the fifth police officer position filled, only to be vacated again when the officer failed to gain entrance to the police academy for his full-time certification. The hiring process for police officers is extensive, and 90% of the candidates do not complete the process. The four full-time officers and two part-time officers have all picked up the workload that allows us to continue to improve the quality of life in New Ipswich. The addition of the fifth officer had a dramatic impact on the rash of criminal mischief and other late night activity that has been bothersome for the past several years. Having two officers on duty during the evening hours not only increases visibility, but officer safety as well. The officers have no idea who they may come into contact with on any given day, and having another officer only moments away can help to resolve many situations safely.

In April 2005, the town of New Ipswich gained national attention when I made the decision to pursue criminal trespass charges against an illegal alien from Mexico. This was the second incident in less than a year in which I was instructed to release persons who had no legal basis to be in the country, who had openly admitted that they had entered the United States illegally. When the federal government indicated that they had no interest in taking custody of the individual from the April incident, I elected to pursue the matter at the state level. Unfortunately, in August, the judge ruled that immigration is solely the responsibility of the federal government. My primary responsibility is to always look out for the safety and security of the residents of the community in which I'm sworn to protect and I will continue to do this even when the federal government will not.

November 2005 marked the end of my third year as Chief of Police, and I believe that significant positive change has come about in those three years. The police department has undergone numerous changes over the past three years, but I believe that the changes were warranted. They have ranged from coverage hours to uniform specifications to the manner in which calls are documented. The number of malicious incidents have decreased dramatically, but we still need your help to control the criminal mischief. If you see something that appears suspicious, it probably is. Please do not hesitate to call the police department at 878-2771.

The statistics for the year 2005 show declines in the numbers compared to 2004, primarily due to the reduction in vandalism calls, but we also saw a greater

number of criminal cases that required a significant number of investigative hours to complete. The statistics for the department are available on our website, [www.nipd.net](http://www.nipd.net).

As always, my door is open, and if I can be of any assistance, please do not hesitate to call the police department or stop in.

## LIBRARY

The Library Board of Trustees began planning for the development of a Five Year Plan that will serve as an assessment document and guideline for Library needs and services in the coming years. This plan will solicit input from representatives of all parts of the New Ipswich community to insure that the Five Year Plan reflects community needs and desires.

The new addition has been completed with the installation of a handicapped access bathroom facility. Finishing touches, such as brass coat hooks, bulletin boards and shelving for "book sale" books will be done soon. The Library's continued appreciation and thanks has been visibly demonstrated with the hanging of a plaque, listing the names of individuals and companies who contributed time, effort, funds and materials for the new addition. Special thanks to trustee John Sterrett for his role in fundraising and as Library liaison during construction.

A new book drop was purchased to replace the old one that had deteriorated beyond repair. Thank you to trustees Tim Somero and Mikko Salokangas who installed the book drop in its present position giving Library patrons a safe place to return books when the Library is closed.

The Library now offers a computer with online access. New Ipswich residents and visitors are welcome to use this service for research and e-mail needs. Wireless service is also available upon request.

More traditional programming includes:

- The Summer Reading Program. This program continues to make summer one of the busiest times of the year. This summer 60 children read over 190 weeks and were awarded small prizes for each week that they read.
- The Mother's Group meets on Tuesday morning at 9 a.m. Mothers and their toddlers and pre-school children meet for games, stories, singing and crafts.
- The Book Club continues their discussion of selected books at 7 p.m. on the first Wednesday of the month.
- Bedtime Story Hour is offered on Monday evenings at 7 p.m.
- Homebound Book Delivery is an outreach service for those who cannot travel to the library by delivering books, magazines and other library materials to those patrons who are homebound.

The New Ipswich Library also continues to support our elementary school by providing class visits to the Library. During these visits, a story is read to the children and each child has the opportunity to check out a book of their choice. In addition, the Library assists and supports pre-school and home schooled students in our community.

Finally, the Board of Trustees and the Library staff wish to extend our thanks to the Children's Fair and the PTA for their generous contributions, and our sincere appreciation to the Town of New Ipswich for its continued support. This support is invaluable and essential in the maintenance of current Library services.

## FINANCE ADVISORY COMMITTEE

- Scope and Chronology of Work

As required under the warrant article establishing the Committee, the Committee continued to assist in the preparation of the budget by establishing standards, scheduling budget reviews and presenting its recommendations to the Selectmen. This budget review work began shortly after Labor Day and ended in January.

However, to prepare for this work, the Committee also met during the spring and summer of 2005. The committee decided to extend its meeting schedule in order to consider issues that arose during the previous budget season but were put aside due to time constraints. The specific issues that were addressed are described in the next three bulleted items.

- Review of Collective Bargaining Agreement

During the summer of 2005, the Committee met several times to review the collective bargaining agreement for Town employees that was not approved by the voters in March 2005. Without taking a position on whether or not the agreement should be approved, the Committee sought to identify how the agreement could be improved. The Committee forwarded its comments to the Selectmen before they started to renegotiate the agreement with the union.

The Committee's critical comments fell into six categories: (1) technical terms should be defined carefully and used consistently; (2) membership of part-time and salaried employees in the union should be reconsidered; (3) compensation and benefit provisions should be less complex and in some cases less generous; (4) the agreement should not unduly limit management flexibility; (5) the Town should not enter into an agreement unless it has the resources to comply with its terms; (6) the Town should have a labor attorney review the agreement.

- New Telephone Service Provider

Last year, the Committee did not recommend any of telecommunications warrant articles because it felt that the Town was building its telecommunications infrastructure in a piecemeal fashion. An important first step was taken in 2005 to improve this situation. David Lage worked with CTC Communications to develop a contract under which telephone expenses (local and long distance) will be reduced significantly. The next step is to determine what changes (if any) in telephone switching equipment are needed to optimize the new CTC relationship.

- Setting Budget Parameters

The first step in the budget process is to adopt a *budget increase percentage*. This parameter is intended to limit the increase in the total budget as well as the increase in the operating budget of each department. In the past, the *budget increase percentage* was set by making an intuitive judgement about what the Town reasonably could afford.

In this budget cycle, the process for setting the *budget increase percentage* was formalized somewhat by using a revenue projection to answer the following question: In light of projected revenue, how much can the Town afford to spend in 2006? Using a revenue projection that had been developed by Malcolm (Kim) Rode, the Committee recommended that the *budget increase percentage* be set equal to six percent. This recommendation was made with the proviso that other spending (via special purpose warrant articles) be tightly controlled.

- Review of Departmental Operating Budgets

The primary responsibility of the Committee is to review all proposed departmental operating budgets. The Committee completed this task in early January. As in the past, the Committee discussed goals and needs with department heads, identified several apparent accounting errors and inconsistencies and recommended specific changes to numerous budget lines. The committee forwarded its recommendations to the Selectmen for their final review and approval.

The most important budgetary recommendation from the Committee concerned the Highway Budget. For the past two years, Highway Department operating expenses have been split between the operating budget and a special purpose warrant article. The committee recommended that budgeting be simplified by eliminating this split. Specifically, the Committee recommended that all Highway Department operating expenses be included in its operating budget and that the special purpose warrant article be deleted. The Selectmen agreed, and this change is reflected in the budget for 2006.

- The most important personnel change reflected in the 2006 budget is the Selectmen's decision to hire a town administrator. With a town administrator in place, it is anticipated that both the Town's day-to-day operations and financial management will become more efficient.

- Review of Warrant Articles

At the time this report was written, the proposed warrant articles had not yet been published. When they are published, the Committee will review them, and its recommendations will be noted on the Town Warrant, as required. It should be noted that this review will become more formal this year in the sense that all warrant articles involving capital expenditures will be evaluated in light of the information and analysis contained in the *Capital Improvements Program*.

- New Deliberative Session Format

The Town holds its Deliberative Session in February so that voters can review the proposed Town Warrant and make appropriate changes before the March vote. To save time, the discussion in past years has focused mainly on the wording of the Town Warrant and only incidentally on issues. In response to numerous comments by voters, the Committee has recommended that the scope of the Deliberative Session be expanded to allow issues to be discussed in greater depth. This new format would make the Deliberative Session somewhat longer and more like a traditional town meeting. The Committee plans to discuss this change in format with the Town Moderator.

## **SOUHEGAN VALLEY AMBULANCE SERVICE**

Once again, Souhegan Valley Ambulance Service (SVAS) has responded to over 400 emergency calls per year to make sure our area residents receive the highest level of quality care that we are able to deliver. Along with responding to emergency calls, our EMTs have provided many community services in 2005. We certified the Greenville lifeguards in CPR, taught the Boy Scouts CPR and the Girl Scouts CPR and First Aid, and along with the Fire Department participated in a mock car accident for Mascenic High School before the prom to highlight the effects of drunk driving. In addition, we have volunteered time and expertise at the following events: Memorial Day Parades, Greenville's 3<sup>rd</sup> of July celebration as well as the Bike Parade, The New Ipswich Children's Fair and the Praise Fest to name a few. We periodically offer CPR and First Aid courses at the SVAS building for community members.

We are honored to have received the EMS Ambulance Service of the Year award for 2005 from Monadnock Community Hospital.

SVAS is aware of the fiscal responsibility we have to the towns we serve. Since billing began in 1999, we have been able to consistently reduce the town's contribution to the Service even though our expenses have risen. Due to the evolution of EMS and the rise in energy costs unfortunately, our budget to the towns has increased this year. Even though our town portion of the budget has increased for the first time in many years, it is still lower than the budget we submitted to the towns in 2002.

The SVAS Board of Directors would like to take this opportunity to give special thanks to all its members and their families and to all the people who assist us in providing emergency care to the community. The dedication of our attendants and the sacrifices of their families add much to the quality of lives here in New Ipswich and Greenville.

## **PLANNING BOARD**

This year the Planning Board has accomplished a lot and has been working diligently towards continuing to update the Master Plan. Over the past year, the Planning Board approved 4 site plan reviews, 5 lot line adjustments, and a condominium conversion, and approved 148 lots, a substantial increase over the previous years. The Planning Board also held a hearing for an appeal for a partial revocation of a site plan review and denied 2 two lot subdivisions.

In addition to meeting twice a month in order to review the applications presented, the Board has also put forward a new steep slopes ordinance as well as new wetlands ordinance and wetland definitions. Both ordinances, if approved, will clarify and help streamline the approval process for the applicant while protecting vital resources for New Ipswich.

The Planning Board is also working with Southwest Region Planning Commission updating two more chapters of the Master Plan, both chapters relating to changes in community facilities and requiring input from all department heads.

Finally, one of the biggest strides the Planning Board has made this year was contacting a consultant and developing a proposal for an impact fee schedule. We have submitted a budget approved by the Finance Advisory Committee that will allow the Planning Board to implement impact fees in the future.

This year I believe the Planning Board has worked very hard to accomplish what has been done and the Board looks forward to continuing to update the Master Plan, implementing the impact fees, and clarifying ordinances and regulations.
